

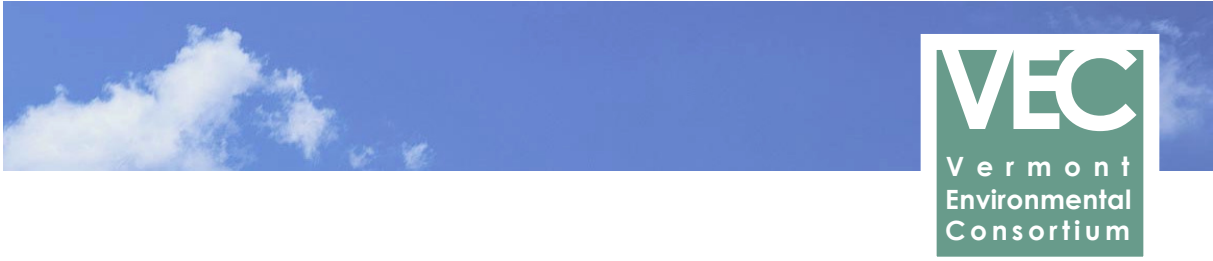

MEMBERSHIP DUES SCHEDULE

- * **Sliding scale dues** are based on the number of full-time-equivalent employees based in Vermont, or full-time-equivalent students attending in Vermont.
- * **Renewal payment** is due each year on January 1.
- * **New members are welcome to join at any time** during the calendar year. Initial dues are prorated, by quarter, based on date of application; full-year payment will be due on the following January 1. Please note that last quarter application dues include membership for the following year.
- * **Affiliate membership** is available for companies without Vermont offices, whose primary activities are not environmental in nature, of which do not otherwise meet standard membership criteria. Affiliate membership includes all standard membership services and rights except voting rights in board elections or membership meetings.
- * **Sponsorship** helps VEC deliver its services and grow Vermont's green enterprise sector. In addition to standard member services, sponsors receive prominent listing and placement of company logo on the VEC Website, promotional materials, and other communications.
